### **ONE-OFF TRANSITION PAYMENT**

Similar to the resurgence, this one-off transition payment will be available from 10<sup>th</sup> December 2021 and closing 13<sup>th</sup> January 2022

### **RESURGENCE 6**

We are applying for the Resurgence Payments for clients who qualify, if your business income has been affected by the change in levels contact our office and we can look at your situation and let you know if you meet the criteria. IRD has increased the assistance; businesses would now receive double the amount.

### **WAGE SUBSIDY 8**

We have had a number of calls about the wage subsidies.

If you think you are eligible and haven't applied yet, contact us.

**The application for Eighth Wage subsidy closes on the 9<sup>TH</sup> December 2021.**

So our charges for the wage Subsidy when you employ up to 2 staff is \$57.5 and \$115 if you employ more than 2 staff.

**Please be aware that if you have received financial assistance from either Wage Subsidies ( which has no GST )or Resurgence Payments( which has GST ) this is Taxable income, for some it may increase your overall annual Revenue and Tax, be prepared and if possible put aside a portion for the Tax Man 😊**

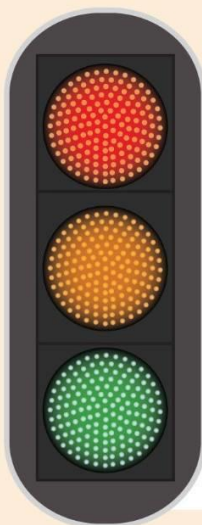

## TRAFFIC LIGHT SYSTEM AT A GLANCE

The new system for Covid-19 response will take effect from 11.59pm on Thursday, December 2.



### Red

- Working from home encouraged. Hospitality, retail, and gatherings allowed for vaccinated but with limits similar to level 2.
- For venues that don't use vaccine certificates - contactless pickup only for hospitality, gathering limit of 10, no gyms or hairdressers.

### Orange

- Close to normal life for the vaccinated, with more masks required and some capacity limits.
- For venues that don't use vaccine certificates - contactless pickup only for hospitality, stricter gathering limits, no gyms or hairdressers.

### Green

- Essentially normal life for the vaccinated, with schools, retail, hospitality all open with no limits.
- For venues that don't use vaccine certificates - some gathering limits, similar to level 2.
